4/6 laning of Trivandrum to Kerala –Tamil Nadu Boarder portion of NH-47
in the State of Kerala

The National Highway Authority of India submitted a proposal for CRZ clearance for the upgradation and widening of NH-47 from Kazhakoottam-Kanjiramkulam sector passing through CRZ III, CRZ II and CRZ I(ii). The proposed road has two river/backwater crossings which are influenced by tidal action and another sector between Thiruvallom and Kovalam passes through the 500m CRZ of the sea coast.

As per the CRZ Notification, construction of road is permissible in CRZ III and CRZ II. The CRZ I(ii) is the inter tidal zone near to the river. Bridges for local inhabitants are permissible in this area.

KCZMA discussed the matter and decided to recommend to MoEF, Govt. of India, subject to condition that engineering solutions will be adopted to avoid damage in CRZ I(ii) areas and necessary scrutiny fee shall be paid.
